EXECUTIVE DIRECTOR'S REPORT

PRO FORMA REPORTS

Executive Director said the Fund has a \$9.5 million year end operating surplus. The Financial Fast Track showed a \$10 million payable to the Coastal and Schools Funds which will be released after the audit is performed in July.

FINANCE COMMITTEE - The Finance Committee met prior to the Executive Committee meeting to discuss dividend options. Executive Director said that the Fund has accumulated more than needed for retention purposes and the transition of the new two funds has been smooth. He reviewed the amounts that are on reserve, which leaves \$7.2 million available for release:

The Committee's recommendation is to release Option 2, \$3,649,375 to its membership. Commissioner Michielli said that committee agreed that since they do not know the impact of the ACA appeal, a lesser amount would be prudent and allow for a dividend of the same amount next year. Executive Director said the finance committee will re-evaluate the financials this time next year.

ADMINISTRATION

REORGANIZATION RESOLUTIONS - At the previous meeting, we did not obtain a quorum. If obtained at this meeting, the reorganization resolutions are included in the consent that will need to be passed by the Executive Committee.

Executive Director said the only major change in the Risk Management Plan is the retention level from \$300,000 to \$325,000. In addition, there is no longer a separate stop loss coverage for prescription only members.

MRHIF MEETING - February - The Municipal Reinsurance Health Insurance Fund met on February 8 to reorganize for 2017. The Committee reviewed the new reinsurance policies which are available for all Commissioners' review. Commissioner Wolk's report of the meeting can be found in Appendix II.

STATE EXAMINATION - The examination by the Department of Banking and Insurance of the SNJ HIF is completed and they are working with the Controllers to finalize the audit. No adverse findings or

recommendations are expected and the exam verified Fund financial statements as of 12/31/2015. We expect to have the final report and an affidavit for the Commissioners to sign at the next meeting.

2017 MEL & MR HIF EDUCATIONAL SEMINAR - The 7th annual seminar is scheduled for Friday, April 21st beginning at 9:00 AM at the National Conference Center in East Windsor, NJ. The seminar qualifies for an extensive list of Continuing Educational Credits including CFO/CMFO, Public Works, Clerks, Insurance Producers and Purchasing Agents. There is no fee for employees and insurance producers associated with MEL and MR HIF members as well as personnel who work for service companies that are engaged by MEL member JIFs and MR HIF member HIFs. 1095 FORMS FOR AETNA MEDICARE ADVANTAGE

1095-B notices

The Affordable Care Act includes a mandate for most individuals to have health insurance or potentially pay a penalty for noncompliance. Individuals will be required to maintain minimum essential coverage for themselves.

In late December through January, CMS will be mailing 1095-B notices to the following beneficiary populations for 2016 tax purposes:

- All individuals under the age of 65 with Medicare Part A;
- Those who enrolled in Medicare Part A for the first time in 2016; and
- Those who had Medicare Part A coverage for part of 2016.

The notices will consist of a cover note from CMS and IRS Form 1095-B. If a Medicare member contacts Aetna with questions about minimum essential coverage, including the Form 1095-B **mailed by CMS**, they should be referred to 1-800-MEDICARE (TTY: 1-877-486-2048) or Medicare.gov

NETWORK UPDATE -LOURDES HEALTH SYSTEM - The Lourdes Health System contract with Aetna has a hard term date of April 1, 2017. The Aetna contract renewal negotiations are ongoing but a settlement has yet to be reached.

Highlights

- For Self-Insured HMO/PPO, Fully Insured PPO, and all Medicare members, beginning on April 1, 2017, Lourdes will be out-of-network.
- Letters to impacted members of Medicare and self-insured plans will be mailed on 02/25/2017. Sample letter is included in the agenda.
- We will send letters to subscribers based on the following criteria:

o Members/covered dependents who have utilized the hospital at least twice in the past 12 months.

Ms. Friel said that a 10 day extension of negotiations was granted before letters are to be sent. Mr. Lodics said there is the potential of a large disruption if negotiations do not pan out, but he is confident that an agreement will be reached.

FUND ATTORNEY: Fund Attorney said at the November meeting, the Fund approved a settlement amount to a suit for one of our members in the amount of \$2500. The settlement was reached at \$2000 and will be paid next week.

AETNA: Ms. Ward said December's claims were high. She said there was one claim from the Schools Fund that was paid a year later, but occurred in 2015. She said she will research why the payment was made so late. In addition, Ms. Ward reviewed the dashboard report which should great network discounts and case management engagement. She said the Performance Guarantee for claim accuracy was missed again in the third quarter, but the claim was not HIF related. Ms. Ward explained the negotiations between Lourdes and Aetna and that notices must be sent 30 days prior to the end of contract.

AMERIHEALTH: Ms. Didio reviewed the Amerihealth NJ and Amerihealth Administrators reports. She said both reports showed run in the beginning of the year so the average is not true to other years.

EXPRESS SCRIPTS: Mr. Rostkowski said that trend continues to decrease and generic has gone up showing a savings of \$400,000. In addition, the mail order pharmacy in Florence is available for tours.
